Dear Child Support Services Participant:

Do you have better things to do than cash your child support check? The Child Support Services Division (CSSD) is offering a **FREE** Direct Payment Card (DPC) to custodial parents receiving child support payments.

It's called the **Alaska Child Support Visa Debit card** and acts just like a check by letting you access your child support payments, only quicker. It lets you buy things **as if you have a Visa** credit card but you're using your **own money**. You can also use it as a **debit card** or to get **cash**.

It's Convenient. No more check cashing fees or waiting in line to cash your child support checks. Use your card for purchases everywhere Visa debit cards are accepted on the internet and in person. The Alaska Child Support Visa Debit Card from JPMorgan is accepted at millions of locations worldwide. You can get cash at ATMs* and bank tellers and get cash back with purchases at supermarkets and many other merchants.

It's Fast. Your child support payments are automatically deposited to your card within 2-3 business days from the day we receive payment from the non-custodial parent. No more waiting for a check in the mail.

It's Safe. No more worries about late, lost, stolen checks, or the need to carry lots of cash. The card carries it for you. If you lose your card, it can be replaced for a fee**.

No Approval Required. You automatically qualify for this card. No credit check or bank account is needed.

Enclosed is an Authorization form for you to fill out and return to CSSD. Once you are enrolled in the program, JPMorgan will issue you the Alaska Child Support Visa Debit Card and a pin number. You must contact JPMorgan and activate your card. The Cardholder Agreement and fee schedule is provided with the card. If you have questions, please contact us at 907-269-6750.

* Regular ATM fees may apply. There is a \$1.50 fee beginning with the 3rd withdrawal each month. You can limit the amount of fees you pay by getting cash back at the same time you make a purchase. Inactivity fees, replacement card and additional card fees are under the fee schedule in the cardholder agreement. There are no program restrictions on use and purchases with the card.
